

## ARTICLES OF INCORPORATION OF

MASTER GARDENER FOUNDATION OF BENTON-FRANKLIN COUNTY.

The undersigned, acting as incorporators under the provisions of the Washington Non-Profit Corporation Act (RCW 24.03), adopt the following Articles of Incorporation for this corporation:

#### I. NAME

The name of this corporation shall be the Master Gardener Foundation of Benton-Franklin County.

#### II. DURATION

The period of duration of this corporation shall be in perpetuity.

### III. PURPOSE

The purposes for which this organization is formed are solely educational and charitable in furtherance of the Master Gardener program in the Counties of Benton and Franklin, without the inclusion of any purpose or intention of carrying on any business, trade, avocation, or profession for profit.

## IV. DIRECTORS

## V. DISSOLUTION

Upon the dissolution of the corporation, the board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization organized and operated exclusively for such purposes as at the time shall qualify for exemption under the said IRS Code section 501(c)(3) or the corresponding provision of any future U.S. IRS Law, as the board of directors shall determine. Any assets not so disposed of shall be disposed of by the court of general jurisdiction in the couty in which the principal office of the corporation is then located, exclusively for such purpose to such organization as said court shall determine, which are organized and operated exclusively for such purposes.
